Please print all information in the tour application form and mail with your deposit of **USD \$600.00 per person** along with a copy of the front page of your passport (with photo). Make checks payable to Sunrise Express Cargo Travel and Tours LLC. Full payment is due ninety (90) days before departure. Be sure to read the General Terms and Conditions prior to completing this application. Your application is not complete until you have read and signed the General Information, Terms and Conditions; Limitation of Liability; and Release and Assumption of Risk form. Kindly take into consideration that space may sell out before the deadline.

BOOKING CONDITIONS:

\$600 deposit per passenger. The deposit is refundable upon cancellation one hundred twenty (120) days prior to departure. After that

We accept lump sum or installment payments. Full payment is due ninety (90) days before departure.

Airline Ticket and Hotel Accommodation is nonrebookable and non-refundable, based on the Airline and Hotel Policies.

No Senior or Military Discounts applicable.

Sunrise Express Cargo Travel and Tours cannot refund independent Airfare purchases or any other services.

Partial Room Cancellation: An additional supplement may apply if a guest cancels or leaves a pilgrimage and a roommate remains.

Passengers who require attention must advise Sunrise Express Cargo Travel and Tours at the time of booking. A qualified and physically able companion must accompany travelers needing such assistance and assume full responsibility for their well-being. Coaches are not equipped with wheelchair-accessible ramps; therefore, all tour members must be able to mount 3 to 5 steps onto the coach.

Participants should expect to walk at least 1 to 3 miles minimum in one day. Walking surfaces may, at times, be uneven.

Rates in this brochure are valid for the travel period stated and are quoted on a person sharing twin/double room basis. All prices are shown in U.S. Dollars and are calculated on currency rates and fares existing on the day the brochure was made.

Sunrise Express Cargo Travel and Tours recommend travel insurance for your travel investment.

An adult must accompany travelers less than 18 years old on the departure date and share the adult's accommodations. Suppose a child will travel with adults other than the parents or with only one parent. In that case, it is highly recommended that a notarized letter be written by the parents or non-traveling parent granting authorization to travel, including the travel dates. We suggest contacting the appropriate consulate and airline because they may have additional requirements.

Sunrise Express Cargo Travel & Tours will make every reasonable attempt to find you a roommate. However, this is not guaranteed. Suppose no roommate is found by the registration deadline. In that case, the passenger can upgrade to a single room (if available) by paying for the single occupancy or cancelling altogether with a full refund. Sunrise Express Cargo Travel & Tours cannot be held responsible if the roommate you were assigned to is not agreeable to you. Suppose you desire to get your own room. In that case, you will be responsible for all the financial consequences of such action, including but not limited to covering the single occupancy costs of both you and your ex-roommate.

Land arrangements are provided as described in the tour program. The tour company reserves the right to change or substitute:

- 1: Hotels for accommodations in similar categories.
- 2: Features of the itinerary to accommodate changes in the schedule.

Obtaining a passport is the sole responsibility of the passenger. Passports must be current and valid beyond the dates of travel. Your airline ticket name must match your passport name, or you may be denied boarding the airplane. Passengers who are denied boarding due to discrepancies between ticket and passport names or because of expired passports accept full responsibility and are subject to the cancellation terms of the tour. Some countries, such as Israel, require that your passport expiration be six months beyond your travel dates. We recommend that you apply for your passports (if needed) at the time of registration.

SUNRISE EXPRESS CARGO TRAVEL AND TOURS TERMS & CONDITIONS AGREEMENT & RELEASE WAIVER

Please read the following terms and conditions carefully. These terms and conditions together with our privacy policy and any other documentation we provide you form the basis of your contract with us (hereinafter The Agreement). This Agreement effects your legal rights. By booking a tour with us, you are accepting and consenting to The Agreement. If you do not agree to the Terms and Conditions, you must not make any booking with us.

The terms “we,” “us,” “our” and “Sunrise Express Cargo Travel and Tours LLC” refer to Sunrise Express Cargo Travel and Tours, which is headquartered in National City, California. The term “you” “I” “participant” or “customer” refers to the customer booking a reservation through us. Reference to “Suppliers” and “Service Providers” means all third parties who provide services to you including airlines and land arrangements unless otherwise specified.

Each tour member must read, understand, and agree to the Agreement including these Terms and Conditions before making the purchase. If you are making travel reservations or bookings for another person, it is your responsibility to ensure that all individuals for whom you make a reservation or booking have read and agreed to these Terms and Conditions. You are responsible, including financial responsibility, for any reservations or bookings you make on your behalf or on behalf of any individual under your direction or control. We will need a copy of each tour member’s passport to confirm your purchase.

BOOKING AND PRICE: You must make payment for your arrangements in accordance with the instructions we give you. If we do not receive any payment due to ninety (90) days in full and on time according to our instructions, we reserve the right to treat your booking as cancelled by you in which case the cancellation charges set out below will become payable. We reserve the right to refuse a booking without giving any reason. Reservations are non-transferable and non-refundable one month prior to departure. However, the price for the tour you have selected will be locked the moment we receive the down payment. Payments made sixty (60) prior to departure are **NON-REFUNDABLE**.

Our tour prices do not include travel and medical insurance or any flight connection. You will need to purchase it independently. You must find the right flight schedule and purchase the airfare before making the tour purchase with Sunrise Express Cargo Travel and Tours. Very importantly, do not purchase a non-refundable or even semi-flexible ticket. You never know if you will need to cancel the trip or, in the unlikely event, Sunrise Express Cargo Travel and Tours will need to. You agree to purchase flights that are fully refundable.

Although our price advertised is quoted rather than estimated, there are some exceptions. (1) The price quoted is based on 2 people per room. If you wish to have your own room, we may be able to offer this at an additional fee, depending on your availability. (2) Some of our customers would like to upgrade to bigger rooms. We offer this service but of course, there are additional fees. For any of these needs, call us for details.

CANCELLATION AND REFUND POLICY FOR THE TOUR (GUIDES, ENTRY FEES, LAND & GROUND TRANSPORTATION & ACTIVITIES): Should you need to cancel your booking, return of your payment will be made in accordance with the table below.

The Cancellation Fees listed here will apply to all reservations, unless the tour booked has specific rates or fees listed under "Special Notes".

No refund shall be given for any portions of the tour unused by the customer after the departure of the tour regardless of any reason.

For tours that include airfare, airfare is completely non-refundable, non-transferrable and non-reroutable.

Hotel bookings and extensions are non-refundable once it is confirmed.

We do not accept changing the tour departure date.

All cancellations requests must be made by email and be effective on the date received by Sunrise Express Cargo Travel and Tours and any all cancellations on the phone will not be honored.

CANCELLATION AND REFUND POLICY FOR HOTELS & AIRFARE: Hotels and airlines serve as third parties for Sunrise Express Cargo Travel and Tours packaged tours. You hereby agree with the hotels and airlines' terms and conditions. In some cases, no refunds are offered. Sunrise Express Cargo Travel and Tours have no control over hotels and airlines' terms and conditions. We-and you-are simply bound by them.

CANCELLATION OR RESCHEDULING BY TOUR GUIDE OR OTHER: In the event the Tour Leader or other entity associated with the Tour Guide chooses to change the departure date, the standard cancellation charges remain effective for the original departure date. Cancellation of a tour without Sunrise Express Cargo Travel and Tours' consent is subject to standard cancellation charges.

CANCELLATION BY SUNRISE EXPRESS CARGO TRAVEL AND TOURS: In the unlikely event Sunrise Express Cargo Travel and Tours- needs to cancel the trip and is unable to reschedule, except in the case of a force majeure as described below, refund will be an option with 25% fees for the tour within 14 business days of the cancellation. Sunrise Express Cargo Travel and Tours has no other obligations to tour members on cancelled trips. This includes but is not limited to any costs and/or fees related to travel insurance, airfare cancellation and travel arrangements you have made outside of this agreement.

FORCE MAJEURE: We cannot accept liability or pay any compensation where the performance or prompt performance of our contractual obligations is prevented or affected, or you otherwise suffer any loss, injury, death, inconvenience, or damage because of circumstances amounting to "force majeure." "Force majeure" means any event or circumstances which we or the supplier of the services in question could not foresee or avoid. Such events and circumstances may include, acts of God, actual or threatened, war, insurrection, riots, strikes, civil action, decisions by governments or governing authority, technical or maintenance problems with transport, changes of schedules or operational decisions of air carriers, terrorist activity or the threat thereof, industrial action, natural or nuclear activity, epidemic, illness, physical injury, quarantine, medical or customs or immigration regulation, delay, or cancellation, adverse weather conditions, fire and all similar events outside our control.

Pandemic/Epidemic: You assume all risks associated with traveling during a pandemic and especially during an epidemic. You hereby agree to release Sunrise Express Cargo Travel and Tours and its suppliers from any issues which may arise from contracting a virus which is spreading locally, regionally, or globally. Furthermore, you do not hold Sunrise Express Cargo Travel and Tours and its suppliers liable for workers and/or other customers not wearing a mask during a pandemic or an epidemic. It is solely your responsibility to always wear an effective mask.

ITINERARIES ARE A SUBJECT TO CHANGE: We are determined to follow the itinerary exactly as advertised to you. Nonetheless, the world is full of surprises, and we need to be flexible enough to work with unforeseen and/or unavoidable circumstances. We reserve the right to update the itinerary at our sole discretion. Uncompleted portions of the tour itinerary are not eligible for any refund. An example is-but is not limited to-heavy rains. Nevertheless, under such circumstances, we will try our best to provide alternative activities comparable in value.

INTERNATIONAL TRAVEL/PASSPORTS AND VISAS: International travel is not without risk. By offering reservations for travel to international destinations, Sunrise Express Cargo Travel and Tours makes no representation, warranty, or guarantee that travel to such areas is advisable or without risk or danger. While we may advise you regarding travel to a destination, it is your responsibility to be aware of travel warnings and advisories that are in effect as announced by your government's foreign policy and relations department. Should you choose to travel to a country that has been issued a travel warning or advisory, Sunrise Express Cargo Travel and Tours will not be liable for damages or losses that result from travelling to the destination.

You and any minors traveling with you must be in possession of a machine-readable passport valid for 6 months after their trip return date along with applicable visas. Some countries require that your passport has two to four blank visa/stamp pages. Some airlines will not allow you to board if this requirement is not met.

Any visa fee or related fees are not quoted in the tour price. You would need to make the purchase independently. All travelers, regardless of nationality, are responsible for ensuring they meet all foreign entry requirements, including all taxes/fees which may be imposed by local authorities. Please make sure all required travel documents are in order upon arrival. Please note that entry to any country may be refused even if the required information and travel documents are complete.

Guests who do not pass immigration of any airport destinations, all tour fees are non-refundable.

For up-to-date detailed information on travel documents and visas, entry/exit taxes and further information on entry and exit requirements please check with your local consular services. Obtaining and carrying these documents is your sole responsibility. Sunrise Express Cargo Travel and Tours bears no responsibility for such information and will not be responsible for advising and/or obtaining the required travel documentation for you, or for any delays, damage and/or losses including missed portions of your vacation related to improper documentation or government decisions about entry.

Disinfection of aircraft is permitted under international law to protect public health, agriculture, and the environment. Several countries that organize trips to choose to do this by spraying the aircraft cabin with an aerosolized insecticide while passengers are on board. Our clients have rarely had any issues with this process, but we note that while the Report of the Informal Consultation on Aircraft Disinfection sponsored by the World Health Organization (November 6-10, 1995) concluded that aircraft disinfection, if performed appropriately, would not present a risk to human health, the report also noted that some individuals may experience transient discomfort following aircraft disinfection by aerosol application. If you have concerns about this process or wish to know more, please consult with your physician.

YOUR HEALTH: It is your responsibility to consult your physician for current recommendations on inoculations and other health precautions before you travel. It is also your responsibility to ensure you meet all health entry requirements and follow all medical guidance related to the trip. Our tours are highly active. Any concerning health issues you may have need to be reported to us before making the tour booking. This includes food restrictions. We reserve the right to cancel your reservation if we think this is in the best interest of your health. In the event of illness strikes you while on a tour, unfortunately no refund will be offered. For this reason, you are required to obtain travel protection insurance. While physically active on a tour, drinking alcohol can be dangerous and is discouraged. Secondhand fumes also can be dangerous. Smoking while near the group is not permitted.

It is essential that you advise us before booking if you do have any disability or pre-existing medical condition which may affect your trip, or if you have any special requirements as a result of any disability or medical condition (including any which affect the booking process) so that we can assist you in considering the suitability of the arrangements and/or in making the booking. Full details must be confirmed in writing at the time of booking and whenever any change in the condition or disability occurs. We will make every reasonable effort to accommodate requests but cannot be responsible if ADA accommodation is not available. Any accommodation provided will be at the sole expense of the guest requiring the accommodation. Please note that accommodations outside of the USA may not follow the Americans with Disabilities Act and may not have wheelchair accessibility.

The tour guides and tour leaders are, unfortunately, unable to offer additional assistance to passengers with limited mobility and all such assistance will need to be provided by whoever the passenger is traveling with. Participants with disabilities must notify us in writing no later than the time of booking of status and of the identity of their non-discounted, paid travel companion who will be responsible for providing all necessary assistance. We may request that you provide a letter from your doctor confirming your fitness to travel.

YOUR RESPONSIBILITY AND CONDUCT: Each participant is expected to act responsibly and adhere to all behavior guidelines established by Sunrise Express Cargo Travel and Tours and our local ground-handlers. Sunrise Express Cargo Travel and Tours and our local suppliers reserve the right to cancel you from a tour, at any time. Reasons for such a decision include but are not limited to-a threat to yourself and/or to others, heavy poisoning, and blatant disrespecting others. You hereby waive and release any rights you may have to make a claim against Sunrise Express Cargo Travel and Tours for expelling you. You also understand and agree that if someone asserts a claim, demand, and/or cause of action against you, you are hereby waiving and releasing any right to seek compensation, indemnity and/or defense from Sunrise Express Cargo Travel and Tours.

When you book lodgings through Sunrise Express Cargo Travel and Tours, you accept responsibility for any damage or loss caused by you. Full payment for any such damage or loss (estimated if not precisely known) must be paid directly to the accommodation owner or manager or other supplier. You must indemnify Sunrise Express Cargo Travel and Tours for the full amount of any claim (also including legal costs) made against Sunrise Express Cargo Travel and Tours. Sunrise Express Cargo Travel and Tours are not responsible for any costs incurred concerning a guest removed from the lodging establishment. You agree not to hold Sunrise Express Cargo Travel and Tours or any of its related entities liable for any actions taken under these terms and conditions.

When you book activities through Sunrise Express Cargo Travel and Tours, you accept responsibility for any damage or loss caused by you. Full payment for any such damage or loss (estimated if not precisely known) must be paid directly to the company owner or manager or other supplier. You must indemnify Sunrise Express Cargo Travel and Tours for the full amount of any claim (also including legal costs) made against Sunrise Express Cargo Travel and Tours. Sunrise Express Cargo Travel and Tours is not responsible for any costs incurred concerning a customer removed from a tour and/or activity. You agree not to hold Sunrise Express Cargo Travel and Tours or any of its related entities liable for any actions taken under these terms and conditions.

Other important notes:

- *Baggage and personal effects* are always the sole responsibility of the participant. NEVER leave baggage or personal belongings unattended, SUNRISE EXPRESS CARGO TRAVEL & TOURS is not responsible for any lost baggage and personal things during the duration of your trip.
- *Tardiness:* Our tours are an exciting experience rather than a military drill. Nonetheless, if you are late, then the group may need to leave without you. In this event, however, we would do our best to customize services just for you, such as by hiring a private vehicle at an additional cost.
- *Tipping:* Tipping is already included in the price, but it is appreciated if a passenger wants to add more. This includes-but is not limited to-bellboys, waiters/servers, bus drivers and local tours guides.
- *Staying in contact:* You will need to have an activated phone with you while on the trip, in the event we accidentally lose each other.
- *Preparing you for departure:* Via email, we will provide you with all kinds of travel tips to help prepare you for this trip, including suggesting a list of what to bring.

Travel Protection: All participants are required to purchase travel and medical insurance for any of our multi-day tour packages. Failing to travel with full-coverage insurance could result in the loss of your travel cost and/or require more money to correct the situation. Without full coverage travel insurance, there may be no way to recoup any losses, costs and/or expenses incurred. It is a requirement for all

participants to secure full coverage travel insurance. At a minimum, such insurance must cover pre-tour cancellations due to personal medical issues, medical expenses related to the tour, flight loss or delays, weather conditions which disrupt touring, in-country political violence, evacuations while on the tour and 24/7 assistance while on the tour. You hereby agree not to seek any such compensation and/or reimbursement from Sunrise Express Cargo Travel and Tours. You also hereby agree to waive Sunrise Express Cargo Travel and Tours from being liable for any aforementioned circumstances.

Sunrise Express Cargo Travel and Tours is not an insurance broker and is not qualified to answer technical questions about the benefits, exclusions, and conditions of travel insurance plans. If you have any questions about your travel protection, then please call your insurance broker. You hereby agree to waive and release all claims you could ever assert/bring against Sunrise Express Cargo Travel and Tours for losses, costs and/or expenses and instead agree to seek compensation from your travel insurance company and/or the on-ground service provider.

Certain countries and airlines have a requirement for foreign visitors to present valid medical insurance before or upon arrival. Sunrise Express Cargo Travel and Tours cannot be held responsible for denial of entry if a guest is unable to provide authorities with proof of acceptable medical insurance or denial of entry for any other reason. No refunds are offered under such circumstances.

ASSUMPTION OF RISK: While Sunrise Express Cargo Travel and Tours does its best to prevent harm, it cannot in any way absolutely guarantee your safety. It is impossible to foresee everything that can go wrong, especially situations that are unknown, unknowable, unanticipated and unforeseeable. Traveling, both abroad and even domestically, involves significant risks and hazards. Additional risks and dangers may arise including, but not limited to, hazards of travel by train, automobile, motor coach, aircraft, vessel and other means of conveyance, animal interactions, forces of nature, political unrest, other unrest, risks associated with water, food, plants, insects and differing animal regulation and acts of national and local governments and unrest and acts of others against governments. These risks are not an exhaustive list but are examples of many kinds of risks. You are voluntarily participating in these activities with the knowledge that there are significant dangers involved, and you hereby agree to accept all risks. Regardless of just how great or unlikely the risks may be, you hereby agree to assume all hazards involved traveling on this tour.

Injuries, illnesses, losses, and general inconveniences can occur anywhere, at any time. In some of the destinations Sunrise Express Cargo Travel and Tours takes its tour members to, there is no ready assistance and/or medical care. Sunrise Express Cargo Travel and Tours do not provide any such assistance. If you have medical issues that put you at any risk in places we plan on visiting, then it is strongly recommended you prioritize your health over your travel ambitions and reconsider whether this trip is in your best interest.

By agreeing to this contract, you hereby agree to waive and release all claims you could ever assert/bring against Sunrise Express Cargo Travel and Tours, regardless of whether they are or are not listed in this agreement. Only some examples of a 'claim' are-but are not limited to-water, food and road/transportation safety, property damage, personal injury, death, theft, strikes, protests, political instability, civil unrest, war, sabotage, outages, terrorism, actions by any law officials, emotional distress, outrage and natural disasters.

By agreeing to this contract, you also hereby agree to waive and release all disputes you could ever assert/bring against Sunrise Express Cargo Travel and Tours, regardless of whether they are or are not listed in this agreement. Examples of a 'dispute' include-but are not limited to food quality, customer service, hotel room satisfaction, suggested activities not included in the tour and not least, daily sightseeing activities.

NON-RESPONSIBILITY Sunrise Express Cargo Travel and Tours is a travel and tours agency that is unique in the sense that it customizes trips in a way that is intended to be motivating, fun and inspirational. Sunrise Express Cargo Travel and Tours and its employees, agents and representatives use third-party suppliers to arrange tours, transportation, sightseeing, lodging and all other services related to this tour. Sunrise Express Cargo Travel and Tours is an independent contractor and is not an employee, agent, or representative of any of these suppliers. Sunrise Express Cargo Travel and Tours does not own, manage, operate, supervise, or control any transportation, vehicle, airplane, hotel or restaurants, or any other entity that supplies services related to your tour. All suppliers are independent contractors and are not agents or employees or representatives of Sunrise Express Cargo Travel and Tours. You agree that neither Sunrise Express Cargo Travel and Tours, nor its employees, agents, or representatives are or may be liable for any loss, injury, or damage to you and/or your belongings, or otherwise, in connection with any service supplied or not supplied resulting directly or indirectly from any occurrence beyond the control of Sunrise Express Cargo Travel and Tours to do so with the third-party supplier and NOT in any fashion with Sunrise Express Cargo Travel and Tours.

Sunrise Express Cargo Travel and Tours assumes no responsibility or liability for any delay, change in schedule, loss, injury or damage or loss of any participant that may result from any act or omission on the part of others; and Sunrise Express Cargo Travel and Tours shall be relieved of any obligations under these terms and conditions in the event of any strike, labor dispute, act of God, or of government, fire, war, whether declared or not, terrorism, insurrection, riot, theft, pilferage, epidemic, illness, physical injury, quarantine, medical or customs or immigration regulation, delay, or cancellation. Sunrise Express Cargo Travel and Tours accepts no responsibility for lost or stolen items. Sunrise Express Cargo Travel and Tours reserves the right to refuse any participant or potential participant at its sole discretion. Sunrise Express Cargo Travel and Tours does not guarantee the quality, suitability, safety, and/or ability of any third-party providers. You agree that the entire risk arising out of your use of third-party

services and any service or goods requested in connection therewith remains solely with you, to the maximum extent permitted under applicable law.

PAYING FOR ADDED SERVICES WHILE TOURING: It is forbidden to pay Sunrise Express Cargo Travel and Tours' contractors for any services whatsoever. Examples include but are not limited to-paying tour guides to show more attractions and paying for more day tours. Unless Sunrise Express Cargo Travel and Tours approve otherwise in writing, all requested add-on services must be paid through Sunrise Express Cargo Travel and Tours. Sunrise Express Cargo Travel and Tours assumes no responsibility or liability for any services paid by the customer directly to the contractor.

ONLINE REVIEWS: You have the freedom to share with the online community your experience with Sunrise Express Cargo Travel and Tours' services. You agree that any review you post online is without bias. You agree to pay the maximum penalty permitted under applicable law should you (1) offer a good review in exchange of monetary compensation, (2) threaten to write a bad review unless you are compensated (extortion) and/or (3) post a review in which false claims can be unequivocally disproved. Furthermore, you agree not to write a negative review should you not immediately (meaning while on the tour) tell-in writing-a Sunrise Express Cargo Travel and Tours representative your concern(s). Examples include but are not limited to-quality of transportation, quality of lodging, presentation of the tour guide and responsiveness of the concierge. You agree to give Sunrise Express Cargo Travel and Tours an opportunity to positively respond to all your concerns while on the tour. Should you fail to inform-in writing- Sunrise Express Cargo Travel and Tours your concern(s) while on the tour, thus giving Sunrise Express Cargo Travel and Tours the opportunity to effectively address it/them, and instead you write a negative review during the tour or even worse, after the tour has finished, then you agree to pay the maximum penalty permitted under applicable law for slander and defamation of character.

You have the freedom to share with the online community your experience with Sunrise Express Cargo Travel and Tours's chosen restaurants. However, very rarely does Sunrise Express Cargo Travel and Tours choose the restaurant for you. On shared tours, Sunrise Express Cargo Travel and Tours has absolutely no control over the restaurants which are chosen. If you wish to write a review about a restaurant Sunrise Express Cargo Travel and Tours did not explicitly require you to eat at, you agree to never post that review on any of Sunrise Express Cargo Travel and Tours' accounts and you agree never to make mention of Sunrise Express Cargo Travel and Tours when expressing your dining experience. Should you post a negative review on any of Sunrise Express Cargo Travel and Tours' accounts and/or mention Sunrise Express Cargo Travel and Tours in a restaurant review for any reason other than Sunrise Express Cargo Travel and Tours requiring you to eat at that restaurant, then you agree to pay the maximum penalty permitted under applicable law for defamation of character.
